**Drop in Care:** Non-refundable, pre-paid punch card. Cards can be purchased at the YMCA member services desk. Cards will be kept at the site that your child attends. Each time your child attends the program, YMCA staff members will mark out punch until all 5 punches are utilized. Example, if your child attends before and after school in one day, there would be 2 punches used. At that time another card will need to be purchased before the child may attend again. If your child is attending for drop in care only and there is a half day of school or 2 hour delay this will be counted as 1 of your prepaid punches.

Full Time Care: 4-5 days per week

Part Time Care: 1-3 days per week

**FIA/DHS Billing Instructions:**

Any family that receives assistances through the Department of Human Services for child care can choose to 1) pay 50% of the weekly tuition per week until the YMCA receives DHS approval papers or 2) wait to start their child in care once the YMCA receives all necessary paperwork. DHS pays a pre-set amount that may not cover the cost of this service. If fees go over pre-set amount the parent/guardian will be responsible for additional cost. For example, DHS pays a percentage of \$2.50. You still may be responsible for part of your childcare tuition. If they pay 100%, it's 100% of the hours your child is in attendance at \$2.50 per hour. If your normal childcare costs are \$80 a week and your child attends for 20 hours a week, DHS will pay \$50 (\$2.50 x 20). You would be responsible for the difference which would be \$30 (\$80-\$50).

**All child care fees are due the Friday prior to the week of service.  
The YMCA does not have a daily rate and does not pro-rate weekly fees.**
